- (一) 現任或曾任教授、副教授。
- (二)中央研究院院士、現任或曾任中央研究院研究員、副研究員。
- (三)獲有博士學位,且在學術上著有成就。
- (四)研究領域屬於稀少性或特殊性學科,且在學術或專業上著有成就。

前項第三款、第四款資格認定之基準,由辦理學位授予之各系、所、院務會議或學位學程事務會議定之。 凡與學生有三親等內之關係者,不得擔任其學位指導教授及學位考試委員。

Notes:

1. According to Article 2 of Establishment of Ph.D. Dissertation Supervisory Committee for Ph.D Program at College of Management, the examination committee is comprised of five to seven members (including the

advisor). At least one-third of the committee body shall be from external institutions and one-third shall be internal faculty.

- 2. According to Article 9 of National Taipei University of Technology Policy of Doctoral Degree Examination, each degree examination committee member shall have research/expertise related to the doctoral candidate's research topic and meet at least one of the following qualifications:
- 1) Employed formerly or currently as full or associate professor;
- 2) Employed as an academician, or formerly or currently as a research fellow or associate research fellow at Academia Sinica;
- 3) Holds a doctoral degree with outstanding academic achievements;
- 4) Has outstanding academic or professional achievements in unusual or specialized fields.

The criteria to determine the qualifications referred to in the preceding subparagraphs 3 to 4 shall be established and approved in a department (graduate institute or degree program) faculty meeting. No committee member can be the spouse, blood relatives or in-laws within three degrees of consanguinity of the student. No thesis advisor or any member of the committee shall be related to the candidate within three degrees of kinship (consanguinity and affinity).
